## When do you need a Mobile Vending Permit?

A permit is required to engage in Street Vending or Vending while moving continuously from place to place on the highways, streets, or sidewalks <u>outside of the Central Business District.</u>

"Street Vending" or "Vending" is defined as selling, offering or displaying for sale, or soliciting another to purchase, for present or future delivery, any goods, wares, merchandise, subscriptions, services, prepackaged frozen desserts, commercially prepackaged foods and beverages contained in displays of less than two hundred (200) cubic feet, or any combination thereof from, in, upon, along, or through the highways, streets, or sidewalks, door-to-door on residential property, or in the open air or from a temporary shelter or vending device upon private property.

This permit expires annually on July 31st.

An ordinance of Council specifying the ward or wards in which the vendor is approved to operate must be passed before a permit can be issued. For more information regarding this permit, please refer to the City of Cleveland Codified Ordinance §675, Street Vendors.

### How to obtain and/or submit a Vendor Mobile Location Permit application:

#### What to bring or submit to the Division of Assessments and Licenses:

- 1) Completed and signed application.
- 2) Two (2) color photos of the mobile vending device (see vehicle requirements for Frozen Desserts).
- 3) Copy of a current and valid government issued identification.
- 4) Copy of your current Retail Food Establishment or Food Service Operation license or Exemption letter from a State of Ohio licensing agency if selling pre-packaged foods and beverages.
- 5) Fee of \$100.00. Fees are payable by cash, check or credit card. This fee is non-refundable. Make checks payable to the City of Cleveland. For email submissions, an Automatic Payment Authorization form must be completed and submitted <u>via secured fax</u> to (216) 420-7804 <u>prior</u> to the application being processed.

### For Pre-Packaged Frozen Desserts Only

In addition to the above information, the following documentation must be submitted for vending pre-packaged frozen desserts:

- 1) Completed Frozen Dessert Affidavit.
- 2) Copy of your State of Ohio BCI check results. Please note that BCI reports will be accepted where the BCI completion date is within one year of application submission.
- 3) Copy of your current Retail Food Establishment or Food Service Operation license from a State of Ohio licensing agency.
